Study description

We used data from the BioTIME database of assemblage time-series, including different taxonomic groups from terrestrial and marine ecosystems, to assess if temporal prevalence trends of populations within assemblages are consistent with a species' global extinction risk. We selected time series with a minimum of 20 years and 10 species, yielding 66,209 populations of 2,362 species across 481 terrestrial and 497 marine assemblages, where each population in each assemblage was classified into one of five categories of temporal prevalence dynamics.
