The HX-MS data processed includes the number of unique and total peptides, as well as their corresponding mass spectra. This data was processed using PIGEON-FEATHER to obtain these values. Data exclusions

Processing of the raw HX-MS data for T4 lysozyme (PXD069693) in PIGEON-FEATHER led to the exclusion of some peptides and timepoints due to noise, measurement error, or peptide degeneracy.

Replication
