Sample size	Sample sizes for each dataset in this study were chosen based on the throughput capabilities of the devices in our lab. Sample sizes were determined to be sufficient in that the computational pipeline developed in this study was able to be fully executed on the available data. To determine whether the sample size was sufficient and did not significantly impact the results, we also tested different subset sizes of a larger dataset with the pipeline, and the results of the pipeline were similar.
Data exclusions	All data is included in the public repository for this study and was included in the analysis. Some data was excluded from the final analysis if it did not pass certain thresholds set throughout the computational methodology developed in this manuscript, which are described in the code and methods section of the paper. Other data was excluded that was measured on different devices for which we could not calibrate to the measurements from the devices used in this study.
Replication	All experiments were repeated at least once and incorporated into the same dataset for training and testing our model, which resulted in similar prediction accuracy for the entire dataset, suggesting experimental reproducibility.
Randomization	Inducer concentration combinations and their positions in the 96-well plates were not completely randomized, though they were not intentionally selected either. Simulated data and the machine learning model training were randomized.
Blinding	There was no blinding in the experiments of this study as the quantitative measurements were performed by an automated device (plate reader) which is blind to the experimental conditions.
