For each set of evolution experiments (4 in total, see Table 1), the number of parallel evolution experiments represents the maximum possible for our high-throughput platform working continuously (9 plates with a total of 864 parallel experiments). The number of different ancestral strains was chosen to maximize the number of different gene-deletions, while allowing for at least three parallel experiments for each ancestral strain and ensuring sufficient controls. The 258 ancestral gene-deletion strains were selected to cover a wide range of initial resistances to the three antibiotics considered in this study while allowing for representatives of different cellular functions, as described in the Methods section.

Samples were excluded if either (1) contamination signs were detected from the sequencing data, or (2) the population went extinct during the evolution experiment. Excluded samples in both cases are provided in Tables S3 and S4 respectively. No additional data were excluded from analysis.

Replication

All evolution experiments were performed in at least three replicates to account for evolutionary stochasticity. Dose-response curves were obtained from growth data from at least three replicates to account for biological variability and measurement errors, except in a few cases explicitly stated in the methods. Replicates yielded reproducible results.
