Seed stocks	A. thaliana Col-0, ddm1-2, rdr2, and rdr6 were obtained from the Colot group. 35S::HA-HSFA2 construct. Col-0 and ddm1-2 were generated by transgenesis
Novel plant genotypes	To generate HSF2A overexpressing lines, HSF2A (AT2G26150.1) CDS was cloned into the ALLIGATOR2 vector ⁶⁷ to generate the 35S::HA-HSFA2 construct. Col-0 and ddm1-2 (G4) plants were transformed via floral dip using Agrobacterium tumefaciens strain GV3101. T2 seeds from three independent transgenic lines (carrying or not the transgene) were selected based on fluorescence, grown in half-strength MS medium (½ MS) under long-day conditions at 23°C. Seven-day-old seedlings of 35S::HA-HSFA2 Col-0 plants and ddm1-2 (G6), and their corresponding transgene-free controls were collected in bulk for RNA extraction.
