We developed a small set of custom R scripts to compile and analyse data and to visualise results. Species distribution maps were obtained from the IUCN Red List database (<https://www.iucnredlist.org/resources/spatial-data-download>), following the terms of use provided by the IUCN. Phylogenetic data were sourced from two published mammalian trees: Álvarez-

Carretero et al. (2022) and Upham et al. (2019). Species life-history traits were obtained from COMBINE database (Soria et al. 2021). Global climatic classifications (as defined by Köppen–Geiger) were downloaded from publicly available datasets (Beck et al. 2018; Galván et al. 2023).

Study description

This study integrates species distributions, phylogenetic data, climatic classifications and life-history traits to evaluate how climatic specialisation and evolutionary time shape diversification and species richness in small mammals. No experiments or manipulations were performed.

Research sample

The research sample consists of 4,231 species and 131 families of small mammals (Rodentia, Chiroptera, Eulipotyphla, Lagomorpha). Data are based on comprehensive global databases and two published mammalian phylogenies.

Sampling strategy

All available species for which distributional, phylogenetic and life-history data existed in published databases were included to maximise completeness and avoid bias. However, for diversification and family-level analyses, families containing fewer than five species were excluded to ensure statistical robustness and to avoid unstable diversification rate estimates associated with very small clade sizes.

Data collection

All data were obtained from publicly available repositories: IUCN spatial polygons, published phylogenies, global climate datasets and life-history databases. No field collection, laboratory work or new data acquisition were carried out.

Timing and spatial scale

This is a global-scale analysis using contemporary species distributions, present-day climatic classifications, and published time-calibrated phylogenies.

Data exclusions

Species lacking either spatial, phylogenetic or life-history information, were excluded as specified in the Methods. Additionally, families

containing fewer than five species were excluded from diversification and family-level analyses to ensure statistical robustness. All exclusion criteria were pre-defined and transparently reported.

Reproducibility

All analyses are fully reproducible using the data and R code provided in the associated repository.

Randomization

No randomization was required as the study did not involve experiments, treatments or assignments.
