Data collection	Root images were scanned by Epson Expression 10000XL scanner. Fluorescent images were taken by laser scanning confocal microscopes Zeiss LSM 780. DIC images were taken by Zeiss Axio Imager 2 system. Root growth parameters were measured by WhinRHIZO Pro2007d software.
Data analysis	Fluorescence quantification was made by Zeiss ZEN microscope software (version 2.6). Virtual ratio images were generated by Fiji software (version 1.52). Relative transcript levels of target genes in qPCR experiment were calculated by geNorm algorithm (version 3.4). Data was analyzed by Microsoft Excel 2016. Statistical analyses were conducted by Graphpad Prism 8 (version 8.3.0). Graphs were plotted by Graphpad Prism 8 (version 8.3.0), and edited by Adobe Illustrator 2020 (version 24.2.1).

For qPCR experiments, 4 independent biological replicates were tested. The statistics and sample sizes were clearly described in the legend of figures.

Replication	All the experiments were performed at least twice by two independent investigators with similar results. All the phenotyping and fluorescent imaging results were successfully replicated, and representative results were shown.
Randomization	In our experiments, seedlings were grown randomly in the growth chamber.
