Life sciences study design

Sample size	The sample size was determined by the number of readings in a period of time based on obtaining the largest amount of data possible to ensure reliable calculations of the target physiological characteristic. Each leaf was measured for more than 1 hour under stable gas exchange conditions.
Data exclusions	No data were excluded a priori, only measurements with known sampling or technical errors such as chamber leaks, power failure, etc. were excluded.
Replication	The theory analyses a physiological response; therefore, each single measurement in one experimental run is considered one replicate. The main experiments to achieve unsaturation conditions were repeated many times in the past 13 years. All repetitions of the experiment and calculations were successful.
Randomization	Different plant species were used in this study, and the measurements were performed on randomly selected plants.
Blinding	A natural physiological response was measured on non-GMO plants, no blinding was needed. Blinding was not relevant because only natural physiological characteristic trait data were required and no group comparisons were made as the comparison was made to the same leaf under benign conditions.
