Study description	This is a simulation study based on a compartmental transmission model. All data used in the analysis are publicly available except for vaccine coverage estimates, which are owned by Gavi, the vaccine alliance.
Research sample	We provide estimates of vaccine impact in 112 countries. These countries were selected through our partnership with Gavi as we have vaccine coverage data from these locations.
Sampling strategy	No sample sizes apply as this is a theoretical study with compartments corresponding to the population size by age group of each country.
Data collection	All data were publicly available except for vaccine coverage, which was provided by Gavi.
Timing	The transmission model involved simulations from 2000 to 2034. All vaccine coverage data through 2022 is estimated and thereafter is forecasted.
Data exclusions	No data were excluded.
Non-participation	There were no human subjects, so there was no non-participation.
Randomization	There were no human subjects, so there was no randomization of participants.
