Sample size	Sample sizes were chosen based on our previous experience and the work from literature. For photoactuation and crawling motion study, at least three different flower-shaped objects and four-armed crawlers were prepared and tested.
Data exclusions	No data were excluded.
Replication	Experiments were repeated at least three independent experiments with similar results.
Randomization	No randomization methods were used because the experimental (PA hybrid) and control samples (covalent network) were prepared separately and tested under the same conditions.
Blinding	Unless specified in the Method section, the investigators were not blinded to allocation during experiments and outcome assessment since our data analysis are based on objectively measurable data.
