Sample size	Samples sizes were not predetermined for cryo-EM. A dataset of consisting of 2575 micrographs in movie mode was collected containing hundreds of thousands of particles as described in the Methods.
Data exclusions	Cryo-EM data processing resulted in exclusion of particles based on image quality and classification as described in the methods. This is a normal aspect of data processing.
