HS-AFM images were first treated with the lab-made software Kodec for noise reduction and flattening. The length and height analyses of HS-AFM images were made using the lab-made pixel-search software program. Histograms were analyzed using Origin. The auto-correlation functions of time-series of height data were calculated using Mathematica v.10.
