Sample size	Structures from individual protein crystals were solved by molecular replacement.
Data exclusions	Datasets were collected at the wavelengths 1.078 Å and 1.033 Å. Diffraction data were integrated and scaled using HKL2000 or HKL3000. Phases were determined by molecular replacement using RimO (PDB 2QGQ) as the search model. This initial model was then refined with rounds of automated model building performed by Phenix AutoBuild, interspersed with manual model building and refinement using Coot and Phenix refine.
Replication	All assay, when relevant, were performed in triplicate and noted. All attempts at replication were successful.
Randomization	Randomization is not applicable to this study.
Blinding	No crystal structure of MiaB was previously described. Thus, blinding was not necessary for this study.
