Proteome extraction from the enamel of 10 fossil teeth aged 1-29 Ma.

Research sample

Enamel powder from 10 fossil teeth aged 1-29 Ma in the Turkana Basin, Kenya.

We sampled large teeth more likely to preserve proteins and removed enamel exteriors to remove potential contaminants

Data collection

Samples were collected at paleontological field laboratories in Turkana, and in Nairobi, both in Kenya, and proteomic data at the Smithsonian in Washington DC.
