Life sciences study design

Sample size	We began our analysis by retrieving all available unique publications (3,078,897) from 42 of the top translational biomedicine journals, which were selected to constitute a large sampling of biotechnology publications, spanning from low-impact to highly-impactful, across a range of sectors within translational biomedicine.
Data exclusions	As the rate of academic publishing prior to 1980 was substantially lower than in the following decades, resulting in a sparser network and different dynamics, and the data after 2020 is not fully populated, we narrowed the scope of our analysis to papers with viable metadata (which is needed for subsequent metric calculation) published between 1980 and 2019.
Replication	Our analysis was replicated by training multiple models on subsets of the full database, in standard cross-validated fashion.
Randomization	Allocation of publications into training and test subsets was conducted randomly.
Blinding	Researchers were blinded to the high-impact labeling and predictions of all journals during execution of the machine learning pipeline.
