Data collection

We used MATLAB (Mathworks) for collapse measurements. We used MATLAB custom scripts, with functions provided by the Vantage 3.3 system (Verasonics), to acquire ultrasound images. The Legikon automated data collection software suite was used for acquiring TEM images. The ZetaPALS particle sizing software (Brookhaven Instruments) was used for DLS measurements. The ChemiDoc imaging system (Bio-Rad) was used for visualizing SDS-PAGE gels. Optical Density of samples was measured using the NanoDrop 2000c software (Thermo Fisher Scientific). All custom code will be available upon request to authors.

Data analysis

We used MATLAB (Mathworks), Excel (Microsoft), ImageJ (NIH) and Prism (Graphpad) for data and image analysis and plotting. Illustrations were made in Affinity Designer and Adobe Illustrator.
