Sample size	This study did not incorporate samples as experimental groups. The number of technical and biological replicates performed for each experiment were based on standards set in the field (and by our lab) for cell-based reporter (Moore 2015, ref 36), FRET (Lee 2016, Tonge 2019, Pollard 2010; refs 26, 33, and 34 respectively), and DSF (Niesen 2007, Methods Ref 8).
Data exclusions	In all cases where data values were normalized, a Grubbs test was performed ($p = 0.05$) to identify outliers among both the positive and negative controls prior to normalizing. For all averaged independent replicates, a Grubbs test was performed ($p = 0.05$) to identify outliers after data had been normalized.
Replication	Biological replications were performed as listed for each type of experiment. Protein expressions/purifications were replicated at least once, in cell FRET were replicated twice, and cell-based reporter assays were replicated twice.
