Data collection	For stereo-seq, RNA from tissue sections was immobilized on a customized 5 cm x 3 cm chip, followed by reverse transcription, tissue digestion, and cDNA purification. The final products underwent purification and quantification, culminating in sequencing on the DNBSEQ™ T10 platform (MGI, Shenzhen, China). For snRNA-seq, nuclei samples were procured from sections adjacent to those used for stereo-seq, sliced at 50-µm thickness and organized by coronal coordinates. The libraries were assembled utilizing the DNBelab C Series Kit (MGI, #940-000047-00), which entailed droplet generation, reverse transcription, and amplification processes. Sequencing was executed on DIPSEQ T1 or T10 sequencers housed at the China National GeneBank (Shenzhen, China).
