We collected the experimental data using d33 meter (YE2730A, APC international, Ltd., Mackeyville, PA, USA), impedance analyzer (Agilent 4294A, Santa Clara, CA, USA), oscilloscope (TDS 5052, Tektronix, USA), an 8-channel ADInstruments data acquisition 422 system (Powerlab 8/26, ADInstruments, Sydney, Australia), NeuroExplorer (Version 5.0, NeuroExplorer). For CPA experiments , Animal movements within each chamber were recorded from above by a high-speed camera and analyzed using the Smart V3.0 (Panlab, Spain).

We analyzed the data by using GraphPad Prism software, MATLAB 2021(MathWorks), OriginLab Software, and COMSOL Multiphysics 6.0.
