Rabbit anti-Phospho-Histone H2A.X (Ser139) antibody (#2577) was purchased from Cell Signaling Technologies (Danvers, MA, USA). Rabbit polyclonal anti-BRCA1 antibody (C-20, sc-642) was purchased from Santa Cruz Biotechnology (Santa Cruz, CA, USA). Mouse monoclonal anti-beta-actin antibody (A1978) and anti-FLAG HRP conjugated antibody (A8592) were from Sigma-Aldrich (St Louis, MO, USA).
Validation	anti-TIGAR antibody was validated in the manuscript by Knockdown in multiple human cell lines. Anti-Phospho-Histone H2A.X (Ser139) Antibody was validated by CST and has been used in 364 publications. Rabbit polyclonal anti-BRCA1 antibody was validated by knockdown and overexpression in different human cell lines by our lab. Mouse monoclonal Anti-beta-actin antibody (A1978) and anti-FLAG HRP conjugated antibody (A8592) were well-documented antibodies and widely used for western blot as shown by hundreds of publications.
