Study description	This work develops a dynamical model of human eye movement behavior.
Research sample	The data were collected as part of a previous study and are freely available at the Open Science Framework (osf.io/caqt2). We used a subset of this data, namely experiment 3. This subset contains the eye movement recordings of 35 participants who viewed 30 images for 10 seconds each. 312, 267 fixations and saccades were detected for further analysis. For the parameter estimation we treated each subject as a separate dataset, and ran the estimation procedure for each individual.
