Sample size	The number of simulation trials (100 for single-synapse simulations, 10 for learning and recall simulations) was chosen such that the effects that we describe would be significant with $p < 0.006$ in a t-test. This is the case for a single observable being greater than zero if zero is not within the standard deviation of the observable (one-sided test), and also for the inequality of two observables if their standard deviations do not overlap (two-sided test, cf. Payton et al., J. Insect. Sci., 2003), because for the chosen number of trials the standard deviation is greater than the 98.8% confidence interval.

Replication	We did not encounter remarkable deviations replicating results with different network structures.
