Data analysis

The data analysis was performed in MATLAB (MATLAB Version: 9.8.0.1380330 (R2020a) Update 2), using a combination of custom code (developed in house) and inbuilt MATLAB functions.

The wavelet analysis used the (MATLAB) wavelet toolbox to calculate the Wavelet Coherence (WCOH) between recordings and the Continuous Wavelet Transform (CWT) for individual recordings. The analysis using the WCOH and CWT was performed using custom software. A description of the methodology is given in the paper.

The spike analysis was performed using custom software based on a previously published work. A description of the methodology is given in the paper.
