Sample size	Five neonates were added to each plant and a mesh pop-up cage was placed (39.25cm x 39.25cm x 59cm) over each infested and zipped closed. The experiment was arranged in a complete random block design with each block containing one cage of each milkweed species. There were 6 blocks of each milkweed with the exception of <i>A. exaltata</i> (4 blocks) due to a limited number of healthy plants, for a total of 30 larvae per milkweed species (20 for <i>A. exaltata</i>) at the start of the experiment.

Replication	N/A
Randomization	Eggs were randomly selected for all experiments and the respirometry trials for our study took multiple days to complete, so butterflies reared on different milkweed species were selected randomly to avoid sampling bias and experimenters were blind to monarch milkweed host.
Blinding	Investigators were blinded to the treatments using codes for all treatments and replications.
