Animal sample sizes were determined using a power analysis performed by G*Power (G*Power, version 3.0.1, Franz Faul; power=0.95, alpha=0.05, effect size=0.5, two-tailed).

Data exclusions

Two animals in the tone/owl-shock group were excluded because they failed to leave the nest within 2 min. Additionally, 6 rats that showed no reaction to shock were removed from the experiment.

Replication

Experiments were performed in smaller cohorts (n=8) with results replicated within each group.
