Sample size	Sample size was determined by the number of virions of each type visible in the microscope under the described experimental condition.
Data exclusions	All recorded cryotomography tilt series were analysed unless rejected based on too few fiducials for alignment, or containing fewer than 3 viral particles. CryoEM subtomograms were included and excluded from averages within the image processing workflow standard image processing techniques such as 2D and 3D classifications. Backplotting of subtomograms to original locations in tomograms was performed automatically based on subtomogram alignment parameters and validated or rejected by visual inspection.
Replication	3 separate virus preparations were grown and analysed by cryotomography for the Wuhan strain, 2 for the Delta variant, and 1 each for the Alpha and Beta variants. One of the Wuhan preparations was studied by for subtomogram averaging, where maps were determined and assessed using independent half datasets, according to standard procedures in cryoEM.
Randomization	Not applicable to this study, as samples were not assigned to experimental groups and data were collected and processed according to standard techniques for cryoEM.
Blinding	Not applicable to this study, as there was no experimental group allocation in data collection and analysis.
