Sample size	Sample sizes were determined based on the information of the existing data in gnomAD, 1000 Genomes, GTEx and ENCODE.
Data exclusions	Genetic variants from gnomAD and the 1000 Genomes that did not pass quality filters (see methods) were excluded from the analyses, as well as insertions and deletions. For cis-eQTL analyses, only SNPs and cis-eQTLs mapping to 1kb and 0.2kb promoters that could be identified (see methods) were considered. For the analysis of ENCODE ChIP-seq data, ENCODE called peaks with IDR scores less than 540 were excluded from the downstream analyses.
Replication	We assessed the evidence for evolutionary constraint in humans over promoter pG4 sequences by using two large public datasets (gnomAD and 1000 Genome project), and two different metrics.
Randomization	In the methods section, how randomization was used to assess the confidence intervals for constraint measurements was described. Otherwise, randomization of samples was irrelevant to this study, since the analyses largely depended on publicly available data.
Blinding	Investigators were not blinded to group allocation during data collection or analyses, as this study relied on the analysis of de-identified, publicly available data sources.
