Data collection

Data of the acid phosphatase activity using pNPP as substrate was collected on a VersaMax microplate reader using the SOFTmaxPRO software.
Isothermal Titration Calorimetry data was collected using the MicroCal VP-ITC calorimeter (Malvern, UK) Origin software.
X-ray crystallography data was collected with the Southeast Regional Collaborative Access Team (SER CAT) at the Advanced Photon Source (Argonne National Laboratory) and processed using HKL2000.

Data analysis

Amino acid alignment was performed with Clustal Omega.
Isothermal Titration Calorimetry data analysis was performed using the MicroCal Origin software by integrating the heats measured and plotting them against the macromolecule molar ratios between the recombinant protein and the ligand. The thermodynamic parameters were estimated by fitting a single binding model to the data points.
The structure complex was solved by molecular replacement with Phaser from the CCP4i suit (8.0.006) using the XcAP-1 model structure predicted by AlphaFold2. The model was manually corrected using Coot (0.9.8.1) and refined with phenix.refine (1.20.1) using a TLS model.
