For RNA-seq, 20-30 animals were pooled for each of the 24 samples. For insitu validation, 10-20 animals were placed in each well

Data exclusions

Technical replicates for replicate 3 in the uncut, 24 and 48 hours after bisection time points were collected, but not utilized in the analysis or uploaded to the SRA.

Replication

For RNA-seq, three biological replicates were included for each time point. For in situ validation, the time course experiment was performed twice, yielding two biological replicates.
