Antibodies

Antibodies used	We used polyclonal anti-Salmonella FlgD, anti-Salmonella FlgE, anti-Salmonella FlgK, anti-Salmonella FlgL, anti-Salmonella FlgM, anti-Salmonella FlhA, anti-Salmonella FlhC, or anti-Salmonella FlhD antibody as the primary antibody for immunoblotting. We sent purified FlgD, FlgE, FlgK, FlgL, FlgN, FlhA, FlhC, FlhJ, FlhM and FlhT proteins to Medical & Biological Laboratories Co., LTD. (https://www.mblbio.com/e/) to prepare the antibodies. We also used anti-Rabbit IgG, HRP-Linked Whole Ab Donkey (GE Healthcare, Cat#SE250-10A-.75) as the secondary antibody.
Validation	Each primary antibody was raised against a Salmonella flagellar protein. These antibodies were already published in our papers.
