Sample size

At the beginning of the study, animals weighed 90 ± 5 g. Sample size was calculated using GPower 3.1.9.2. Calculations were based on previous data obtained in the laboratory of body weight variations, body temperature, hormonal changes, cognitive functions and energy expenditure changes in mouse lemurs exposed to acute RSV. Based on the predicted differences and setting the power at 90% on repeated measures (effect size = 0.25, alpha error probability = 0.05, 4 repetitions), 15 animals were required in each group. Therefore, we planned to study at least 30 mouse lemurs exposed to either an ad libitum regimen with or without RSV supplement. Group assignment was not performed randomly, animals were divided into two dietary groups that were matched for body weight, age and pedigree: a control group (CTL) consisting of 15 animals fed the standard diet described above, and a RSV group of 18 animals that were fed the same diet but received RSV supplementation.

Briefly, 33 male grey mouse lemurs were included in the study beginning at 40 ± 6 months of age, considered an adult age in this species in captivity. At the beginning of the study, animals weighed 90 ± 5 g. They were then divided into two dietary groups that were matched for body weight, age and pedigree: a control group (CTL) consisting of 15 animals fed the standard diet described above, and a group of 18 animals that were fed the same diet but received RSV supplementation.
