Sample size

Considering the yawning activity of animals, we realized that about 20 subjects were sufficient to provide an appropriate number of events to train the AI and to test for the difference between yawning and breathing events. N=22 was a more than sufficient sample to test the phenomenon of yawn contagion also considering the data available in the literature.
