The data size for cryo-EM was determined based on the available microscope time and the quantity of particles on the grids. Sufficient cryo-EM data were collected to achieve the reported resolution of the map, which is adequate for model building.
Data exclusions	In cryo-EM data processing, poor-quality or damaged particles were removed, and micrographs with low CTF fitting resolution were excluded. Only high-resolution and homogeneous particles were retained through standard data classification procedures to achieve high-resolution maps.
