Replication Time-course experiments were performed at least in duplicate in different days and data collected were used for quantification of FWHM, GFP/TMR intensity and co-localization. Phenotypes found through microscopy, including 3D localizations, were successfully replicated. Single-cell super-resolved time-lapse microscopy were done at least in duplicate in different days for YutH- and CotY-GFP and once for the additional GFP fusions.
