Sample size was set at 3 (repeated experiments on different coral microcolonies). The sample size was not increased because coral culture is technically demanding, microcolonies being difficult to grow and maintain.

Data exclusions

No data were excluded

Replication

Experiments were repeated 3 times per treatment on biological replicates (coral colonies)

Randomization

There was no need for a formal method of randomization. Colonies were taken individually from identical conditions in culture aquaria.

Blinding

The samples all came from the same coral culture conditions. Analysis could not be carried out blind because the operator had to perform individual treatments on each coral microcolony.
