Data collection	For the sequence data, we obtained it through high-throughput and PCR amplification sequencing, as well as from the NCBI Nucleotide database.
Data analysis	For the sequence data, we performed multiple sequence alignment using MAFFT in PhyloSuite. We estimated divergence times with BEAST v.2.4.7, conducted biogeographic inferences with BioGeoBEARS, reconstructed ancestral habitats using RASP v.4.0, and performed multi-line plotting and departmental analysis with the segmented function in R.

Wild animals	Specimens were captured in the field using either fishing nets or angling. Deceased specimens were retained for analysis. For live specimens, they were anesthetized with Tricaine (150 mg/L) to obtain fin clips. Following the procedure, the fish were monitored until they fully recovered and were then released back into their native habitat.
Reporting on sex	For the collected fish specimens, non-invasive and harmless sex identification was not feasible. Furthermore, as our study design did not incorporate sex-based analysis, sex was not determined for the samples.
Field-collected samples	Tissue samples were obtained from each specimen and preserved in 95% ethanol. Upon returning to the laboratory, they were transferred to and stored at -80°C for subsequent analysis.
