Sample size

No formal statistical method was used to predetermine sample size. Independent culture dishes were considered biological replicates, whereas individual FOVs/cells were considered technical/image-level replicates. Sample sizes are reported in the corresponding figure legends. For model development, 550 co-registered NAD(P)H/mitochondria image pairs were acquired from 6 culture dishes and split into training, validation, and test sets at a 7:1:2 ratio. Downstream analyses were performed on FOV/cell-level measurements sampled across independent culture dishes, including n = 112 FOVs per group for Fig. 4, n = 16 FOVs for Fig. 5, n = 16 fibroblast and n = 13 mammary epithelial cell FOVs for Fig. 6, and n = 16 FOVs at 0 h and n = 28 FOVs at 2, 4, and 6 h for Fig. 7. Because statistical analyses were performed at the FOV/cell level rather than after aggregation to dish-level means, the reported statistics should be interpreted as image-level trends within the tested datasets rather than fully independent biological replicate-level effects.

Data exclusions

out-of-focus images acquired during automatic imaging were visually excluded. During image analysis, predicted mitochondrial images were binarized to remove intensity variations, and segmented features smaller than the minimum expected mitochondrial size ($>0.5 \mu\text{m}$) were filtered out because they were considered likely background artifacts.

During model development, an independent test set was used to evaluate performance on unseen data. We further assessed day-to-day acquisition transfer using a secondary paired-image dataset acquired during an independent imaging session on a different day, without additional model fine-tuning. Experimental findings were further evaluated across multiple settings, including comparison with stain-based reference images, application to label-free fibroblast images, testing in an independent cell type (hTERT-HME1) without additional training, and validation under FCCP-induced mitochondrial perturbation across replicate cells and time points.
