Data collection

Whole genome sequencing was performed using HiSeq 2500 (2x150bp).

Data analysis

Raw reads were processed through Trimmomatic tools to remove poor-quality reads. Filtered reads were aligned to the *Thlaspi* reference genome v.1 using bwa-mem v0.7.17-r1188. Aligned files were then processed through Samtools v1.9 and Picard 1.83 tools to remove PCR duplicates, assign read groups and for sorting. Variant calling was performed on each of the mutant aligned files separately with the GATK tool Haplotype Genotyper v3.3. The Haplotype Genotyper tool allowed for detection of SNPs and indels.
