Study description	A dietary shift from animal-based to plant-based food could reduce greenhouse gas (GHG) emissions from direct agricultural production and increase carbon sequestration if spared land is restored to its potential natural vegetation. Changing food behaviours in high-income countries thus provides an opportunity for a double carbon dividend. We investigate this dividend when national average diets shift to a planetary health diet proposed by the EAT-Lancet Commission in high-income nations. We linked a new physical Food and Agriculture Biomass Input-Output (FABIO) table (including 128 agricultural sectors and 191 countries) with spatially explicit harmonized aboveground biomass carbon (AGBC), belowground biomass carbon (BGBC), soil organic carbon (SOC), and greenhouse gas emissions (GHG) to trace annual GHG emission reduction and long-term carbon sequestration in potential natural vegetation.
