Study description	Here, we employ the fixed effects model to estimate the effects of air temperature on river water quality and elucidate inverted U-shaped responses through 276 Chinese cities from 2014-2020. Our results demonstrate that both single-day high temperatures (>37°C) and heatwaves (four consecutive days above 35°C) significantly increase river permanganate index (CODMn) concentration, worsening organic pollution.
Research sample	Data from 276 cities across mainland China were used to represent spatially diverse river water quality and climatic conditions.
Sampling strategy	No experimental sampling or randomization was involved. The analysis relied on long-term monitoring and meteorological data. The sample size (276 cities) was determined by data availability and spatial coverage of national monitoring networks, which were sufficient to ensure robust statistical inference.
Data collection	All datasets used in this study are publicly available and their sources are described in detail in the Methods section.
Timing and spatial scale	The dataset covers the period from January 2014 to December 2020, with monthly observations aggregated at the city level. The spatial scale of analysis corresponds to the administrative boundaries of 276 Chinese cities.
Data exclusions	Cities or time points with missing or inconsistent records were excluded. Exclusions were based solely on data completeness and quality control; no subjective criteria were applied.
Reproducibility	All analyses were conducted using R and Stata. The analytical procedures and models are fully reproducible using the described methods and publicly available data sources.
Randomization	Randomization was not applicable, as the study is based on observational data rather than experimental manipulation.
Blinding	Blinding was not applicable to this study because the analysis was based on publicly available observational data without human or experimental subjects.
