Study description

Analysis of the mass flowering event of the seagrass *Posidonia oceanica* at Mediterranean scale following the marine heatwaves of 2022

Research sample

Research samples correspond to quantitative or qualitative measure of the flowering intensity of *Posidonia oceanica* (proportion of shoots bearing an inflorescence) or just occurrence or not of flowering.

Sampling strategy

sampling strategy was opportunistic by constituting a Pan-Mediterranean corpus and gathering quantitative or qualitative data about flowering at Mediterranean basin scale.

Data collection

Data was collected by the authors mainly by scubadiving (in situ observation) or by lepidochronology analysis or by qualitative field observation.

Timing and spatial scale

Data collection started in September 2022 and ended in July 2024.

Data exclusions

Qualitative data corresponding to stranded inflorescence or fruits/seeds observations were discarded prior to statistical analysis
