Data exclusions	No data were excluded from the analysis; however, a filter was applied to the segmentation mask to exclude oocytes smaller than 10��m or larger than 100��m in diameter, in order to remove artifacts from the segmentation.
Replication	All the experiments involving mice were performed using at least 5 animals for each age group, with the exception of mated vs virgin ovarian reserve comparison where 4 animals were used. Sample availability for human cortex strip is limited and two donors were included in this study.
Randomization	All experiments were performed on isolated ovaries, chosen from randomly picked mice from the colony. All the animals used in this study were chosen randomly and blinded. Both human participants were chosen by our collaborators in the hospital without our knowledge.
Blinding	Image quantification was performed with consistent methods identical for all images, using automated object segmentation unless stated otherwise.
