Population characteristics	The age range of the patients was 1 to 20 years with a mean age of 9 ± 5 years, and a female-to-male ratio of 0.52. All patients in the study were scheduled for an appointment with an audiologist and were undergoing tympanometry as part of their clinical visit.
Recruitment	Parental permission was obtained for participants under the age of 18 years. Children age 7 to 17 provided written assent. Assent was obtained after parental permission was granted. Children age 7 to 12 signed a simple assent form and children age 13 to 17 signed a consent form. Parents co-signed the consent form. Participants 18 years and older signed a consent form. Patients who were undergoing tympanometry as part of their clinical visit were recruited during routine audiology appointments.
