Study description	In this study, we provide qualitative and quantitative analysis of racial bias in GPT models with respect to 4 races.
Research sample	In total, this study uses 400 PubMed articles as source input, and generated 36,800 generated responses that covers different bias evaluations with respect to White, Black, Asian and Hispanic race. These responses are specifically designed to assess biases across four racial groups: White, Black, Asian, and Hispanic. This selection spans a spectrum from data-rich to underrepresented categories, ensuring a broad coverage in the evaluation of racial bias.
Sampling strategy	We sample from the last 4% in chronological order of the Pubmed articles included in PMC-Patients (a large dataset of Pubmed articles) to ensure that the selected cases are not seen by the model during training.
Data collection	Data are collected with GPT-3.5-turbo version 0301 and GPT-4 version 0613 using version 2023-03-15-preview Azure API.
Timing	Data are generated from August 2023 to November 2023.
