Data analysis	All analyses were conducted using scripts in Python and MATLAB, built on openly available toolboxes and resources. Mapping of Allen Human Brain Atlas microarray data to the Desikan–Killiany atlas was performed using abagen. Molecular PET templates were obtained and integrated via neuromaps, and ENIGMA case–control structural effect-size maps were accessed through the ENIGMA Toolbox. Meta-analytic functional decoding used Neurosynth association maps, and MEG power spectra were processed in Brainstorm. Statistical testing included spin-based permutation procedures (Vasa method) and PCA implemented in Python; visualisations were produced with Matplotlib and Seaborn.
