Study description	Quantitative-experimental.
Research sample	The study sample included female undergraduate students from Tel Aviv University, 21-30 years old. While not fully representative of the general population, they reasonably reflect the university's student body.
Sampling strategy	To determine the required sample size, we conducted an a priori power analysis using the pwr package in R (Champely, 2020) for a logistic regression with four predictors. We calculated the sample size needed to detect a moderate odds ratio of 1.2 (converted to an approximate f^2 of 0.067 for the power calculation) with 80% power. The analysis indicated a required sample size of 179 samples. To account for the nested structure of our data, we calculated the design effect (Kish, 1965) using a small intraclass correlation coefficient (ICC = 0.05) and cluster size of 4 which is the number of decisions at each part for each dyad. Adjusting for this design effect resulted in a final required sample size of 206 samples which is 52 dyads.
Data collection	To capture EMG data we used X-trodes facial EMG electrode arrays. To capture decision making during experiment we used Microsoft Bluetooth number pads. Experimenters applied the EMG electrodes on participants' faces, and then went behind curtains and ran an automated script without interacting with the participants. Thus, although experimenters were aware of the general hypothesis, this did not affect the interaction with the participants.

Timing	Start : November 20, 2022. Stop : December 27, 2023.
