Genewise read counts for cells with a least 500 reads were exported from Cell Ranger to Matrix Market format files and read into R with edgeR's read10X function. An average of >33 million reads and >6200 cells were obtained for each sample. Each 10x library was individually quality checked and cells were filtered to ensure good gene coverage, a consistent range of read counts and low numbers of mitochondrial reads. At least 500 detected genes were generally required for each cell. Cells with exceptionally high numbers of reads or genes detected were filtered to minimize the occurrence of doublets. An average of 5000 cells per sample remained after this quality filtering.
